

## RULES AND REGULATIONS

---

Since 2016, MEDFILM Festival started a professional platform **MEDMeetings** aiming to offer a space for encounters between euro-mediterranean cinema professionals to encourage exchanges and collaborations.

For its 27th edition, MedFilm Festival is happy to launch the 2nd edition of **WORKS IN PROGRESS** workshop.

MedFilm *Works in Progress* is addressed to feature narratives and creative documentaries in the phase of post-production coming from Spain, France, Monaco, Italy, Slovenia, Croatia, Bosnia and Herzegovina, Montenegro, Albania, Greece, Cyprus, Malta, Turkey, Syria, Lebanon, Palestine, Egypt, Libya, Tunisia, Algeria, Morocco, Iraq, and Jordan.

### 1. Date and location

The second edition of MedFilm *Works in Progress* will take place from **8th-10th November 2021** during the 27th edition of *MedFilm Festival* which will take place in Rome (5th - 14th November 2021).

### 2. Award and jury

The **MedFilm grant (10.000 euros in cash)** will be awarded by an international jury. Other grants will be announced by September 6th.

### 3. Description of the workshop

MedFilm *Works in Progress* will take place on the **8th and 9th November**. Each duet of director and producer will be invited to defend and debate his/her film during a discussion with the jury members.

A one to one meetings session with industry guests will be organized on **10th November**.

Due to the situation related to Covid-19, the discussions and meetings will be **online**.

### 4. Eligibility

MedFilm *Works in Progress* is addressed to feature narratives and creative documentaries in the phase of post-production coming Spain, France, Monaco, Italy, Slovenia, Croatia, Bosnia and Herzegovina, Montenegro, Albania, Greece, Cyprus, Malta, Turkey, Syria, Lebanon, Palestine, Egypt, Libya, Tunisia, Algeria, Morocco, Iraq, and Jordan.

The rough cut submitted duration must **not be less than 40 minutes**.  
The submitted version must be **subtitled in English**.

### 5. Application

To register to MedFilm *Works in Progress* it is necessary **to fill in the Application Form**, which can be **downloaded from the website [www.medfilmfestival.org](http://www.medfilmfestival.org)**, and send it together with the other requested documents to the following e-mail address: [professional@medfilmfestival.org](mailto:professional@medfilmfestival.org)

### 6. Selected Films

The selected films will receive a notification by **october 10th 2021**.  
The selection of a film must remain confidential until the official announcement of the Festival.

### 7. Awarded films

The winning film must include "**With the support of MedFilm Festival 2021**" with MedFilm Festival logo and the name of the Award assigned in the credits and in any documents related to the film.

### 8. General Terms

Registration for the MedFilm *Works in Progress* implies the unconditional full acceptance of these Regulation.

The Application Form is an integral part of these Regulation.

The Direction, after appropriate legal counsel, will settle all questions relating to the MedFilm Festival by applying these General Regulations, also available in Italian. Should any dispute arise regarding the interpretation of these regulations, the original Italian version is to be considered binding. Any controversy that might arise with regards to the interpretation, execution or resolution of the present Regulations will be deferred exclusively to the court of Rome.
